

# FARE CHANGE EQUITY ANALYSIS

MTA seeks to roll-out additional ways to pay for fares by introducing the Go Pass Smart Card and Mobile App, convenient and contactless ways to pay when riding MTA's primary and regional route services.



### **Benefits of Go Pass**

- Contactless payments via Smart Card or Mobile App
- Automatic fare capping (1 day, 7 day, and 30 day periods)
- Free transfers when using Go
  Pass
- Purchase via mobile app stores, customer service centers, or online

## Why Choose Go Pass

The Go Pass offers an easier and more secure way of purchasing passes and includes benefits such as no charge for transfers and "best fare" pricing with fare capping. When a patron uses the Go Pass Smart Card or Mobile App, it will automatically cap the price paid in a 1 day, 7 day, or 30 day period. Passengers will still have the option to pay for fares with cash.





MTA is conducting a Title VI Fare Change Equity Analysis to ensure that fare modifications are equitable and meet the diverse needs of the community. We are inviting public participation to provide feedback and insights into the proposed changes.
