Marcia introduced herself and shared she is legally blind. She relies on services like MTA for her transportation.

**MINUTES:** Clara Blakley motioned for the April minutes to be approved with the correction of "Steve Lowe" to be changed to "Steve Low" and VAAA's Senior Power Day date to be corrected to May 22nd, 2024. Allison Gute seconded the motion with those corrections. The motion carried.

#### OLD BUSINESS:

- ADA Certification Process- No update TDN is absent. MTA will be sending a letter in June to highlight the GO-PASS. MTA is also getting individuals in to get there GO-PASS.
- Member Vacancies There are 3elderly and/or disabled member vacancies.
- The Safe Streets Grant & The Safety Action Plan FRP's are being revised to have a smaller scope. Once the FRP's are complete and available Dru will notify LAC. If anyone has any questions, please feel free to submit them to Dru Hajec and she will pass them along to Kris Garris.
- Electronic Accessibility Ed Burger viewed the OWL video system and MTA's technology department has approved it for purchase. It was noted that some agencies who host LAC need notice to get with their technology departments to get access to wifi in order to use the OWL.
- New TDN representative is Besh Besh will be now giving ADA application updates

### **NEW BUSINESS:**

- Introduction of prospective member, Marcia Lewis. Macia shared that she has been legally blind for 4 years. She keeps herself busy with her two dogs, exercising, and gardening.
- Rene motioned to accept Marcia as a member of LAC. Clara seconded- motion was carried.

## **SENIOR SERVICES INTRODUCTION & SERVICES:**

The Office of Senior Services manages all 7.1 million senior millage dollars. Their is currently 37 contacts with service providers. These programs service clients 60 years and older and include transportation, legal services, lawn care, meals on wheels, in home care and many other services,

## STATUS REPORT & SERVICE REPORT – Ed Burger from MTA Your Ride:

- A friendly reminder we have a mileage renewal coming up later this year.
- Increasing an expanding Grand Blanc station to include hydrogen buses, rides to wellness, a canopy and charging station.
- MTA is also expanding the emergency response trailer. In order to make this successful MTA works with local fire departments to appropriately and safely respond to vehicles with different fule/energy sources.
- MTA is dealing with many changes in traffic with the increase in summer construction. MTA is continuing to increase their on-time arrival.
- Your Ride provided 29,901 rides in May, 17,610 of those rides were ADA rides and 3,473 of those rides utilized a lift.
- MTA is evaluating current services to ensure they are meeting the community need.
- Go-Pass is still on track; the transition to Go Passes is underway. Even with this change MTA will always accept cash and accommodate those rides.
- Clara asked about VA out of county rides. Traci shared an update that last month VA upped their VA rides to one out of county ride per month. Each community partner has different criteria. Traci will send a list of community partners to Sabrina to share with LAC.
